



2024 Candidate Survey

Williamson, Bobby (Governor)

1. ***Abortion is the act of violently ending the life of another human being, while in the womb. Lawmakers should work to promote the value of and protect human life from conception (SB 317, 2024;) to natural death, versus further expansions of abortion access (HB 110, 2024; SB 301, 2024; SB 232, 2024; HB 400, 2022, HB 31, 2023).***
 - a. Support; It's not a position of lawmakers. It always goes back to the healthcare providers. It's the lawmakers role to focus on crime, safety, etc. Further expansions also include the chemical castration, especially of minors; that is also a form of abortion that lawmakers shouldn't allow. Abortion still being used as birth control is a disgrace to society.
2. ***The Delaware Constitution should be amended to protect the right of parents in the custody, control, and care of their children from government interference, which requires the government to prove that it has a strong, compelling reason to restrict that right, such as in cases of abuse and neglect. (HB 319, 2022)***
 - a. Support; Parents have the right to raise their children. In an environment of abuse, that is when the restricted hand of government is to get the child help, and work with the parents to get help and restore their rights when possible.
3. ***Public schools should not seek to enforce DEI (Diversity, Equity, and Inclusion) mandates, which promote discrimination by dividing individuals into classes of "oppressed" and "oppressor", and define inclusion as requiring integrated comprehensive sex education curricula that includes LGBTQIA+ role play, sexual practices, and identities (HB 199, 2021, SB 197, 2024).***
 - a. Support; Public schools are there to teach the basics. It's not for them to push any social agenda whatsoever. Sex ed needs to be reigned in so children are not taught sexual content too early. Parental approval for content is necessary.
4. ***Delaware law should protect minors from the harms of pornographic material by requiring websites available in Delaware to perform age verification procedures that are standardized from usage in other industries. (HB 265, 2024).***
 - a. Support; Delaware laws should protect children from any harms. This includes things like alcohol, cigarettes, firearms too. We have to put any barriers possible to protect children.
5. ***Delaware law should protect Title IX fairness and the integrity of women's sports. (SB 191, 2024)***
 - a. Support; No matter what a surgeon's knife does, your chromosomes are what they are. Women have fought hard. We should do more than just protect, we need simple common sense.
6. ***Individuals and faith-based entities should have the right of conscience to freely live out their sincerely held convictions regarding human sexuality and conception, without fear of government infringement or retaliation. (HB 199, 2021; HB 275, 2024; HB 74, 2023)***

- a. Support; Of course they should. It's not government's place to control religion. That goes for all religions.
7. ***Medical personnel should not be protected from liability for practicing experimental medical drugs and procedures - which often produce irreversible damage - on vulnerable minors in Delaware. (HB 346, 2024).***
- a. Support; All people should be held accountable in their actions. Accountability is for all, including politicians or people that want to harass trans individuals. That accountability goes for other experimental drugs like the COVID vaccine. They didn't do responsible pharmaceutical testing.
8. ***Assisted Suicide, the act of prescribing "death pills" so that individuals given a terminal diagnosis to end their life, should not be legalized in Delaware as an 'end of life' option. (HB 140, 2024)***
- a. Support; We have to restrict what is allowed by assisted suicide. Compassion and pain management is necessary, but legal assisted suicide will lead to their pain or illness being leveraged against them to die.
9. ***A State of Emergency declaration extended beyond 30 days should depend on the consent of the people of Delaware through the General Assembly. (HB 49, 2021; HB 247, 2021)***
- a. Support; As soon as the extent of the emergency is understood, the Governor should go to the legislative body to decide the best way forward. It shouldn't just be in the hands of the one after a certain period of time. It also depends on the type of emergency.
10. ***The right of Delawareans to keep and bear arms, as protected by the US and DE Constitutions, should not be infringed. Better enforcement of current laws to prevent crime versus more regulations is needed to protect public safety. (HB 450, 2022; SB 8, 2021)***
- a. Support; It's a constitutional right. Period. There are too many backdoor bills that they're doing to aggravate the gun owners. This will lead to them ultimately taking their right to own guns, the guns, and then their ability to protect themselves. If gun owners can't protect themselves, their homesteads could be taken too. Public stores shouldn't allow ammo in the open, but there are allowances for things like dedicated firearm stores or gun shows.
11. ***To preserve the integrity of Delaware elections, the legislature should strive to eliminate opportunities for fraud in the election process. (HB 344, 2024)***
- a. Support; Of course they should. We need to recreate a new system to make sure the ledgers are right. We need fair and adequate elections.
