THE SANCTITY OF LIFE

Website states, "I believe strongly in protecting women's reproductive freedom. I am proud that Delaware codified Roe v. Wade in our state constitution (2017) to ensure that women's healthcare decisions are made in the privacy of a doctor's office and not by politicians in Dover or Washington, DC. [...] That means advocating to secure Delaware as a haven from so-called 'restrictive' states."

Website states, "We cannot afford to allow federal pronouncements to encroach upon and destroy the personal freedoms that define us as a society."

Website states, "We must continue to protect and implement the laws we have passed, especially as the gun lobby seeks to weaken them through lawsuits and bills in the General Assembly that attempt to dismantle the work accomplished to date. We must work now to implement the 'Permit to Purchase' bill signed into law last year."

Website states, "This includes ensuring easy access to multiple voting methods, especially amending our state constitution to permit 'no excuse' absentee voting."

Website states, "I support recent legislation passed protecting the right to abortion and access to reproductive healthcare. Reproductive freedom is essential to personal autonomy and public health."

PROTECT GIRLS' SPORTS

Website states, "I support the rights of LGBTQ Delawareans and am committed to ensuring full equality and protection under the law."; Co-sponsored HCR 59 (2019), which considered federal religious exemptions allowing religious organizations to honor their sincerely held beliefs "attacks" on the LGBTQ community.

PROTECT RELIGIOUS LIBERTY

Co-sponsored HCR 59 (2019), which considered federal religious exemptions allowing religious organizations to honor their sincerely held beliefs "attacks."

STOP ASSISTED SUICIDE

Co-Sponsored HB 140 (2019) to legalize assisted suicide.

PROTECT THE 2ND AMENDMENT

Co-sponsored HB 63 (2019), making it a misdemeanor if a person has a firearm that is used to commit a crime by another person; though that person did not commit a crime themselves, their "unsafe firearm storage" is enough to give them a misdemeanor.

SUPPORTS THE SANCTITY OF LIFE

I believe in providing resources to women facing unplanned pregnancy to support the health of both the mother and the child during pregnancy and early life of the child.

KEEP CRT/DEI OUT OF SCHOOLS

DEI is often cast as the modern equivalent to anti-discrimination or equal opportunity laws and regulations. It is a destructive influence that interferes with the healthy culture and operation of successful companies.

PROTECT GIRL'S SPORTS

Biological males should not be allowed to compete in women's sports. These situations create a danger to women in contact sports and rob biological women of competitive opportunities and scholarships. Title IX was specifically designed to expand sports opportunities for women and allowing biological males to compete inherently undermines that purpose.

PROTECT RELIGIOUS FREEDOM

Society has established norms for social behavior, marriage and families. Not everyone agrees on these standards, but absent clear harm, people should live and let live with respect for those differences. Especially important are the religious beliefs and practices. The "state" can not impose religious standards or practice on the populace, but a healthy republic requires the active participation of religious citizens to provide a stable, moral influence on our society.

PROTECT MINORS FROM GENDER MUTILATION

Protecting healthcare workers from legal liability is a back door route to implement and support many controversial activities - abortion throughout the term of a pregnancy, sex-change operations on minor children and others. These issues of public concern and debate should be addressed openly and debated, rather than furthered by legislative action that effectively enables them while not confronting the issues directly in a public discussion.

STOP ASSISTED SUICIDE

Enabling suicide is not the role of healthcare providers and many will refuse to participate. Services, such as hospice, are available and effective at managing the comfort and support of patients and families facing end of life situations.

LIMITED GOVERNMENT

Executive authority must have checks and balances. There are legitimate needs for independent and rapid action by the Executive Branch, but extended use of that authority allows and requires oversight by the Legislative Branch. Emergency Action should not be allowed to repeatedly renew, as it did during the Pandemic.

PROTECT THE 2ND AMENDMENT

The right to protection of self and family is fundamental in the law. Delaware's Constitution is even more protective of these rights than the 2nd Amendment to the U.S. Constitution. The focus must be on criminals and criminal activity and it should be implemented in a way that least impacts on law-abiding citizens and their freedoms.

PROTECT FAIR ELECTIONS

I believe in proof of citizenship to register to vote and in the requirement for confirmation of identity when voting. Voting is a fundamental right and it must be strongly protected. Our life is full of examples where ID's are required and commonly accepted. I don't quite understand the reluctance to enforce ID requirements for voting, unless there is intent to violate the rights of citizens.





SUPPORTS THE SANCTITY OF LIFE

1

Abortion is the act of violently ending the life of another human being, while in the womb. Lawmakers should work to promote the value of and protect human life from conception (SB 317, 2024;) to natural death, versus further expansions of abortion access (HB 110, 2024; SB 301, 2024; SB 232, 2024; HB 400, 2022, HB 31, 2023).

SUPPORTS PARENTAL RIGHTS

2

The Delaware Constitution should be amended to protect the right of parents in the custody, control, and care of their children from government interference, which requires the government to prove that it has a strong, compelling reason to restrict that right, such as in cases of abuse and neglect. (HB 319, 2022)

KEEP CRT/DEI OUT OF SCHOOLS

3

Public schools should not seek to enforce DEI (Diversity, Equity, and Inclusion) mandates, which promote discrimination by dividing individuals into classes of “oppressed” and “oppressor”, and define inclusion as requiring integrated comprehensive sex education curricula that includes LGBTQIA+ role play, sexual practices, and identities (HB 199, 2021, SB 97, 2024).

SUPPORTS PROTECTING MINORS FROM PORN

4

Delaware law should protect minors from the harms of pornographic material by requiring websites available in Delaware to perform age verification procedures that are standardized from usage in other industries. (HB 265, 2024).

SUPPORTS PROTECTING GIRLS' SPORTS

5

Delaware law should protect Title IX fairness and the integrity of women’s sports. (SB 191, 2024)

SUPPORTS PROTECTING RELIGIOUS FREEDOM

6

Individuals and faith-based entities should have the right of conscience to freely live out their sincerely held convictions regarding human sexuality and conception, without fear of government infringement or retaliation. (HB 199, 2021; HB 275, 2024; HB 74, 2023)

SUPPORTS PROTECTING MINORS FROM GENDER MUTILATION

7

Medical personnel should not be protected from liability for practicing experimental medical drugs and procedures - which often produce irreversible damage - on vulnerable minors in Delaware. (HB 346, 2024).

STOP ASSISTED SUICIDE

8

Assisted Suicide, the act of prescribing “death pills” so that individuals given a terminal diagnosis to end their life, should not be legalized in Delaware as an ‘end of life’ option. (HB 140, 2024)

SUPPORTS LIMITED GOVERNMENT

9

A State of Emergency declaration extended beyond 30 days should depend on the consent of the people of Delaware through the General Assembly. (HB 49, 2021; HB 247, 2021)

SUPPORTS PROTECTING THE 2ND AMENDMENT

10

The right of Delawareans to keep and bear arms, as protected by the US and DE Constitutions, should not be infringed. Better enforcement of current laws to prevent crime versus more regulations is needed to protect public safety. (HB 450, 2022; SB 8, 2021)

SUPPORTS PROTECTING FAIR ELECTIONS

11

To preserve the integrity of Delaware elections, the legislature should strive to eliminate opportunities for fraud in the election process. (HB 344, 2024)
